Shiloh Baptist Church may use part of the center as a classroom for suspended kids.

EASTON — When a young pawas going to serve his 10-day suspension from school hanging out at McDonald's, Davis decided there had to be a better place for idle youngsters to go.

Once the church buys the original Larry Holmes Training Center, which could happen Tuesday, Davis says there will be an alternative to running the streets, where he sees endless

temptations to get into trouble.
